Notice of Temporary Prohibition of Through Traffic Order

Road Traffic Regulation Act 1984 - Section 14


Denbighshire County Council intends not sooner than 7 days from 23rd June 2021 to make an Order prohibiting vehicles using that length of the road known as Rose and Crown to County Boundary at Rhydtalog Bridge (B5430), Graianrhyd, which extends south-eastward from its junction with the road known as Graianrhyd Farm Junction Opposite Rose and Crown to Aber Tainant Lane to the county boundary for a distance of approximately 2km.

The closure is necessary to facilitate overhead line works by Sunbelt Rentals. Pedestrian access will be maintained throughout the period of closure.

The signposted alternative route will be via A5104, Rhyd y Ceirw County Boundary to A5104, Rhyd y Ceirw Junction to County Boundary, School Junction to Area Boundary, B5430 Llanarmon yn Ial Junction to Graianrhyd County Primary School.

The Order is effective from 12th July 2021 for an eighteen month period or the earlier completion of the works whichever is soonest. The works are expected to last approximately until 16th July 2021.

Mae angen cau'r ffordd er mwyn i Sunbelt Rentals wneud gwaith ar y gwifrau uwchben.

Bydd mynediad ar gael i gerddwyr drwy gydol y cyfnod cau.

Bydd y llwybr amgen yn mynd ar hyd yr A5104, Ffin Sirol Rhyd y Ceirw i'r A5104, cyffordd Rhyd y Ceirw i ffin y sir, cyffordd yr ysgol i ffin yr ardal, B5430 cyffordd Llanarmon yn lâl i Ysgol Gynradd Graianrhyd.

Daw'r Gorchymyn i rym ar 12 Gorffennaf 2021 am ddeunaw mis, neu lai os cwblheir y gwaith yn gynt. Rhagwelir y bydd y gwaith wedi'i gwblhau ar 16 Gorffennaf 2021.
